### Invitation of Bids

- The government of Nepal has allocated funds towards the cost of the contracts decreed in Contracts Description Table (CDT) at end of this notices and intends to apply part of the fund to cover eligible payment under the contract for Construction of Following works in the Following project, for which this tender invitation is issued.
- The Mahawai Rural Municipality, Office of the Rural Municipality Executive, Padmghat, Kalikot invites electronic bids from eligible bidders for the Construction of Following works.
- Bidding documents, may be purchased and submission of a written application, attested copies of registration firm valid for F/Y 2079/80, VAT registration certificate, Tax clearance certificate of F/Y 2079/80 and upon payment price within the office hours up to 2080/07/10 (27/10/2023). Interested eligible bidders visit e-procurement section of PPMOs website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp)
- The purchased bid documents shall be submitt from bolpatra website. The bid must be submitted to the on or before the deadline of 2080/07/10 (27/10/2023) at 12:00 hour. The accepted Bids shall be opened at Mahawai Rural Municipality, Office of The Rural Municipality Executive, Padmghat Kalikot in the presence of the Bidder's representatives who choose to attend at above date and time (last day of submission). Non-attendance of any or all of the Bidders' representatives shall not hinder the opening of the Bids.
- Bid opening date and time: 2080/07/10 (27/10/2023), at 13:00 PM.
- If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Account No. .0726101704190042 krishi bikash bank sakha karalaya, padamghat, Kalikot and should submit the receipt of the deposited amount of cash along with the Bid. For the purpose of Bidders their bid electronically through E-procurement section of PPMO's Website <http://www.bolpatra.gov.np/egp> the Bidders must choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the instructions to Bidders. In case the Bidder choose to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document (as specified in the below table) in the Office's Rajaswa (revenue) account as specified in the Notice and electronic scanned copy (PDF format) of the Bank deposit voucher also should be submitted along with the electronic bid documents.

- The Bidders are invited to participate in the Pre-bid meeting on the 2080/07/3 (20/10/2023) at 10:00 A.M. at Mahawai Rural Municipality, Office of the Rural Municipality Executive, Padmghat, Kalikot.
- In case the last date of purchasing of bid documents falls on government holiday the purchasing can be made on the next working day. Similarly, if the last day of submission falls on government holiday then deadline for submission shall be the next working day. The time for purchasing and submission remains same as above.
- Bids must be valid for a period of 90 days and must be accompanied by bid security as mentioned in the table below in cash deposited in Account No. 0726101704190042 krishi bikash bank sakha karalaya padhmaghat, Kalikot or in the form of bank guarantee in favor of Mahawai Rural Municipality, Office of the Rural Municipality Executive, Padmghat, Kalikot as per standard format provided in Bid documents (Contract No. should be clearly mentioned, otherwise will not be accepted). Bid security validity period for tender shall be 120 days from the date of bid opening.
- Bidders are advised to visit the Construction Site and access the actual site conditions before submitting their Bid.
- Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 and Public Procurement Regulations-2064 and other prevailing regulations.
